Payment

Payment is required before services are performed. Hurry, classes fill up quickly and are on a first-come, first-served basis. To register and guarantee your seat, payment must be received at least 14 business days prior to the date of the course.

Refund / Cancellation Policies

If you cannot attend the Certified Food Handler Course/Exam or need to reschedule to another date, please notify us within 14 business days of the course date to receive a 75% refund on the course/exam fee or to reschedule. You may notify us by phone at 800-429-7110. If you cannot attend on the day of the course, you may send another employee in your place without penalty. There are no refunds or reschedules 14 business days before the course or if you fail to show up for the course/exam. If you miss your scheduled course/exam date, you will need to register and pay again. If FS&T cancels the course due to low enrollment, you may choose another course date or a full refund. We cannot refund you for study materials (books, etc.) or postage once the material(s) have been sent in the mail. Important Information

If you require special accommodations, please advise us before registering.
